**STALLS:** Total of 145 stalls available. The facility has 55 covered full size stalls – 33 with a covered aisle and 22 without a covered aisle. There are 22 stalls made with Powder River six panel 10' by 10' stalls (they will have a tarp at the back wall and other tarps will be available for side walls, if desired) that are under a large covered building with open sides. There are also 18 stalls (double goat stalls) 48" walls that are 5' x 10' and 50 stalls (double sheep stalls) with 42" high walls that are 5' x 10' both of which will be under a large covered building with open sides – we would appreciate all that can use these to do so.

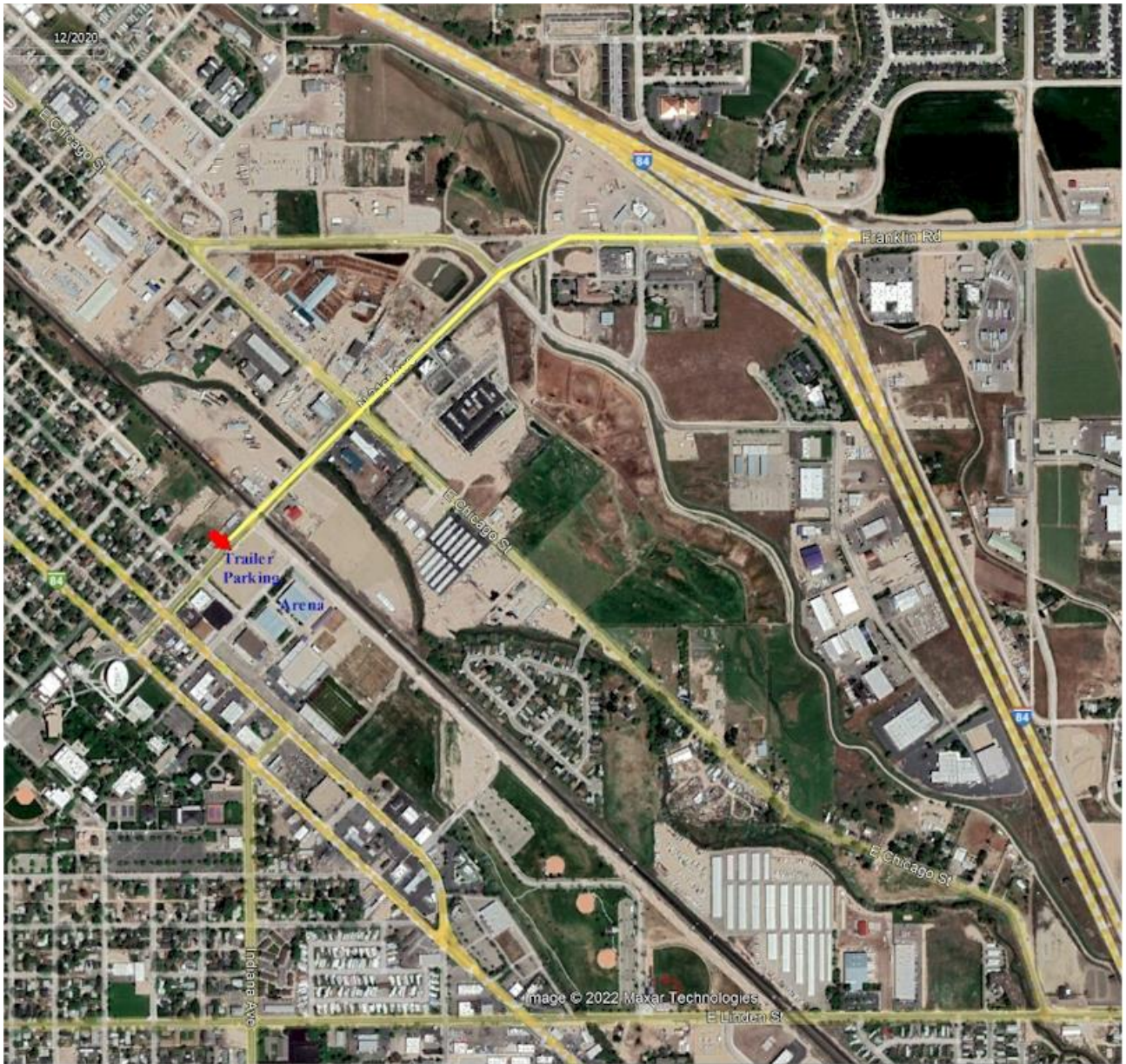


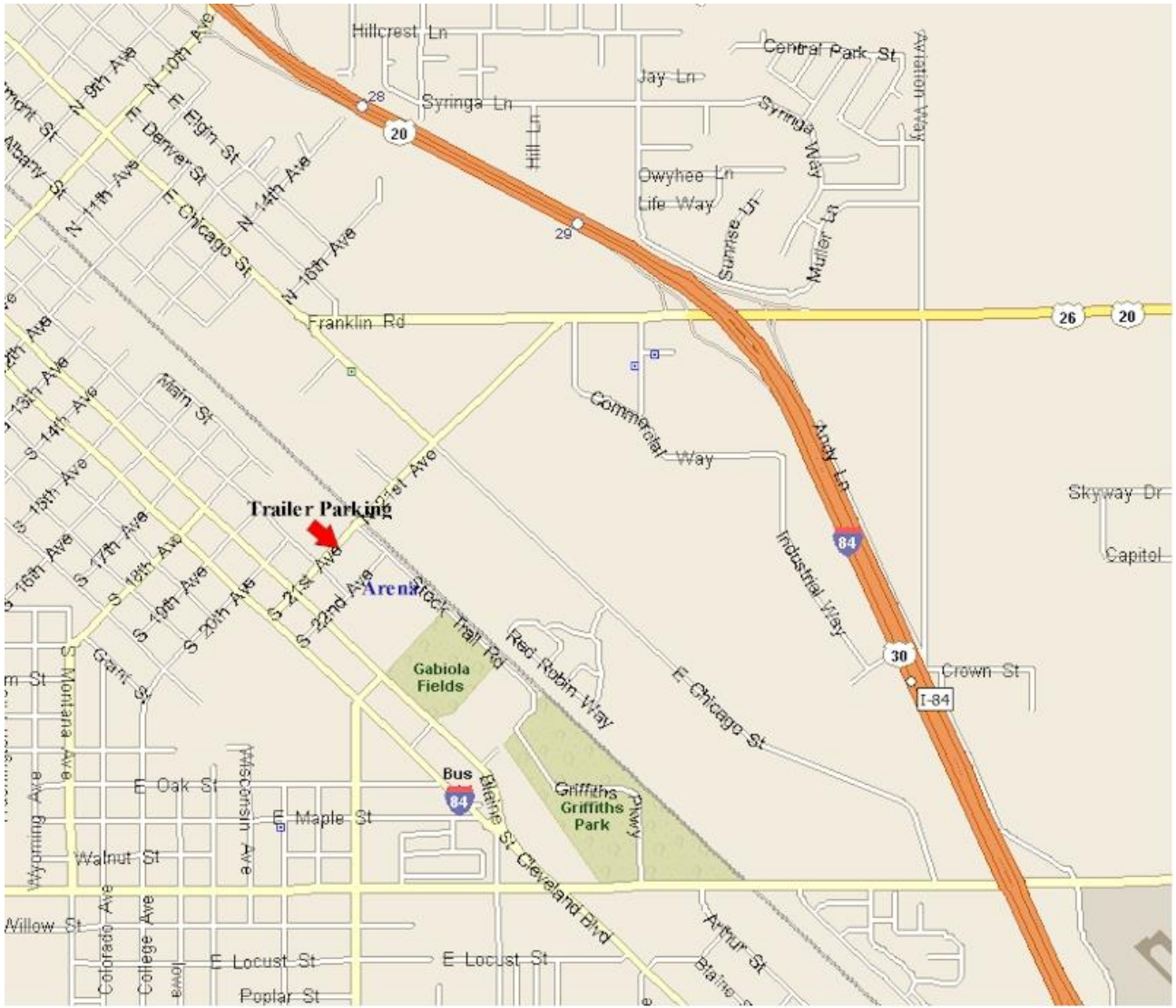
### **Location & Directions:**

Interstate I84 westbound from Boise: Take Exit 29, turn left at stop light onto Franklin Road which turns into N. 21<sup>st</sup> Avenue with a left jog. Continue just over railroad tracks and **EITHER** turn left into large open lot for trailer parking just past Stock Trail Road to the left **OR** instead, continue straight on S. 21<sup>st</sup> Avenue to Cleveland Blvd (a One-Way Street going east). Turn left at the light, get into or stay in the left lane. Turn left at S. 24<sup>th</sup> St./Indiana Avenue which takes you to Blaine Street (a One-Way Street going west). Turn left on Blaine Street and get in the right lane as you will turn right on S. 21<sup>st</sup> Street (going back the way you came in) until you get to the trailer parking area. If you get to Stock Trail Road, you have gone too far -- turn right on Stock Trail Road and right again to get to the facility west entrance.

Interstate I84 eastbound from Ontario Oregon: Take Exit 29, turn right at stop light onto Franklin Road which turns into N. 21<sup>st</sup> Avenue with a left jog. Continue just over railroad tracks and **EITHER** turn left into large open lot for trailer parking just past Stock Trail Road to the left **OR** instead, continue straight on S. 21<sup>st</sup> Avenue to Cleveland Blvd (a One-Way Street going east). Turn left at the light, get into or stay in the left lane. Turn left at S. 24<sup>th</sup> St./Indiana Avenue which takes you to Blaine Street (a One-Way Street going west). Turn left on Blaine Street and get in the right lane as you will turn right on S. 21<sup>st</sup> Street (going back the way you came in) until you get to the trailer parking area. If you get to Stock Trail Road, you have gone too far -- turn right on Stock Trail Road and right again to get to the facility west entrance.

## Rules:

- NO REFUND ON STALL FEES
- Refunds will be given only upon receipt of veterinarian certificate for the event.
- NO refunds for missed classes: It shall be the exhibitor's responsibility to watch the progression of the show.
- Checks returned for non-sufficient funds shall incur a \$35 return check fee.
- Ring procedure: the management shall expect all exhibitors to have familiarized themselves with the official rule book of AMHR/ASPC. Any horse that becomes a threat to an exhibitor, audience or other animal may be asked to leave the ring, or to be removed from the show grounds.
- Two-minute gate rule: Once the class is called, the gate steward will begin timing for all entries to enter.
- It is the owner/handler/exhibitor's responsibility to be on time for classes. Announcements to barn areas are a management courtesy – not mandatory.
- Changing Classes: Exhibitors must fill out a class change form which must be done before or after the show or during breaks. Must be done before the desired class enters the ring. Payment or arrangement for payment to be done at this time.
- Gate Holds: Gate holds MUST be given to the gate person 4 classes in advance and in writing. Gate holds will be for a maximum of 2 minutes expect for harness changes which will be allowed 5 minutes.
- Amateur/Youth Classes: Amateur and Youth must provide a copy of their current Amateur or Youth card. Applications for Amateur and Youth memberships will be available in the show office.
- Lunch/Dinner Breaks: Will be left to the discretion of the judges and show management. However, we will not break until a division is complete. Example- if we are on a yearling mare class, lunch will not be held until after the Grand Championship class, etc.
- Back numbers: No back numbers will be issued until entries are paid or arrangements made with management.
- Facilities: Indoor arena does not have stalls located inside. Absolutely no lounging in the show arena. Stalls are located adjacent to the arena. Wash racks are available. Please provide your own hose. Please do not wash in the aisles, roadway or other areas. Practice jumps will be made available to use.
- Dogs are allowed only in barns and **must be on a leash**. No dogs allowed in the arena or other buildings. Please clean up after your animals.
- No smoking in stalls or buildings.
- No horses on concourse except for in measuring area during measuring time.
